Sir,

We wish to begin with passing our sincere condolences, on the calling of our beloved Queen Elizabeth II, to Gods mercy only last month.

We write however, to draw your Majesties attention to those who would harm your most loyal subjects, usurp your Majesties Imperial Crown, and overthrow the Constitution of your Majesties United Kingdom of Great Britain and Northern Ireland, and the Religion, Laws, and the Liberties of the Subject.

Wicked, and Evil counsel may deceive you Sir, into the believe that as a Constitutional Monarch, Sir does not have the power, nor right to intervene in matters of concern to your loyal subjects, we humbly draw your Majesties attention to the *stare decises* in *Godden V. Hales* ((1686), 2 Shower, 475), in which eleven, of the twelve judges concurred;

1. That the kings of England are Sovereign princes;

2. That the laws of England are the king's laws;
3. That therefore it is inseparable prerogative in the kings of England to dispense with penal laws in particular cases and upon particular necessary reasons;
4. That of those reasons and those necessities, the king himself is sole judge, and then, which is consequent upon all;
5. That this is not a trust invested in, or granted to, the king by the people, but the ancient remains of the sovereign power and prerogative of the kings of England, which never was taken from them, nor can be.

As a consequence of this judicial ruling sir, a strong and rigid Constitution was installed by your Majesties noble predecessors William III, and Mary II, with the convention English Parliament, and the convention of Scottish Estates, added the *Coronation Oath Act 1688*, Bill of Rights [1688], and the *Claim of Right Act 1689*, to the pre-existing Treaties, and Statutes not limited to but including *Magna Carta 1215*, and *Petition of Right [1627]*, to which of course was added the *Act of Settlement (1700)*, giving guarantees the loyal subject, would face arbitrary and despotic power, no more.

Sir, we note and draw your attention to the wicked and evil counsel, which led to our beloved Sovereign becoming a subject of the European Union, and now must draw your attention to the evidenced sedition, and treason

within the *European Union (Withdrawal Agreement) Act 2020*, with the parliament of Elizabeth II, declaring itself Sovereign.

We have reported this matter to a number of your Majesties attested Police Constables, who have refused to take action in this matter, notwithstanding their personal attestations to your highness, they have worshipped mammon (wages/money), instead of God (law), in contravention of holy scripture, recorded within *Matthew 6:24*.

We have reported the matter to Westminster Magistrates Court, and attempted to commence proceedings by way of Private Criminal Prosecution, that was blocked by a legal advisor to the Court known as Anthony Marballie at 12:27, on the Thirteenth Day of March 2022, purportedly as we had not completed the correct form, or process.

We have also noted, and draw your attention sir to a further Two Private Criminal Prosecutions that were blocked by Deputy Senior District Judge Tanweer Ikram, whom we understand is the line manager of Anthony Marballie, in regards to Robin Budenburg the Chairman of Lloyds Banking Group and evidenced fraud, we also note sir, and it would be irresponsible not to draw your Majesty's attention to the fact, that this man is the chairman of your public estate, and this may also expose your Majesty to

loss (financial), in event this mans dishonesty is proven, as the irrefutable evidence suggests it will be.

The other matter relates to Pandemic Fraud raised by our noble and honourable friend David Laity, a retired Detective Inspector of good standing, for and on behalf of the Peoples Union of Britain, in June 2021.

A further Private Criminal Prosecution was blocked in April 2022 by Westminster Magistrates Court in April 2022, that had been submitted to another Magistrates Court on the Twenty First day of December 2021, in relation to multiple murder's committed by health professionals, using the controlled drug Midazolam, once again raised by our noble, and honourable friend David Laity.

We are aware your Majesty of a Three-year statute of limitations under the Treason Act 1695, and that the first offences we identified occurred on the Twentieth Day of December 2019, and due to the difficulty defending your Majesties Birthright, and the Constitution of the United Kingdom of Great Britain and Northern Ireland, from the evidenced traitors in both Houses of Parliament, bring this to your Majesties attention, and also raise this matter with the Lord Chief Justice, Lord Burnett of Maldon, and enclose a courtesy copy of this letter for your reassurance and peace of mind.

We are unsure Sir, as the system of courts has been wilfully obfuscated since the Glorious Revolution, if we may apply directly to the High Court, in such a serious matter, but have applied to Mr Justice Sweeney, a High Court Judge of Kings Bench Division, and enclose a courtesy copy of this letter for your reassurance sir, and peace of mind.

We once again apply to Deputy Senior District Judge Tanweer Ikram, at Westminster Magistrates Court, and pray our application is processed now it shall be under Royal scrutiny, we do not understand why our previous application was rejected when it is clearly a matter of national security, given the evidenced allegations, and enclose a courtesy copy of this letter for your reassurance sir, and peace of mind.

We raise this matter with the Metropolitan Police, who have a clear and unremitting duty to uphold the law including the *Treason Felony Act 1848*, and have made an attestation they may be held accountable, should they break this, and enclose a courtesy copy of this letter for your reassurance sir, and peace of mind.

We raise this matter with the Lord Speaker, of the House of Lords, who to date we have no evidence of any involvement on the part of Lord McFall of Alcluith in this evidenced treachery against not only sir, and his Birthright, but the Constitution of the United Kingdom of Great Britain and Northern Ireland, which is our own Birthright, granted through S.IV Act of Settlement

(1700), and therefore places a clear and unremitting duty upon this man, to impeach those responsible for endangering the happiness, and the security of the nation, and enclose a courtesy copy of this letter for your reassurance sir, and peace of mind.

We raise this matter with the Mr Speaker, of the House of Commons, who to date we have no evidence of any involvement on the part of Sir Lindsey Harvey Hoyle in this evidenced treachery against not only sir, and his Birthright, but the Constitution of the United Kingdom of Great Britain and Northern Ireland, which is our own Birthright, granted through S.IV Act of Settlement (1700), and therefore places a clear and unremitting duty upon this man, to impeach those responsible for endangering the happiness, and the security of the nation, and enclose a courtesy copy of this letter for your reassurance sir, and peace of mind.

We raise this matter with the Archbishop of Canterbury, of the Lords Commissioners, who to date we have no evidence of any involvement on the part of Justin Portal Welby in this evidenced treachery against not only sir, and his Birthright, but the Constitution of the United Kingdom of Great Britain and Northern Ireland, which is our own Birthright, granted through S.IV Act of Settlement (1700), and therefore places a clear and unremitting duty upon this man, to impeach those responsible for endangering the

happiness, and the security of the nation, and enclose a courtesy copy of this letter for your reassurance sir, and peace of mind.

Due to the difficulty to date, bringing those evidenced committing felony against sir, and the Constitution to justice at this time, in accord with the customs of your subjects sir we convened a grand jury of your loyal subjects on the Fourteenth Day of October 2022, where it was established no less than One Thousand, One Hundred and Forty-eight men, and woman, who swore personal oaths, or made affirmations of allegiance to our late, and beloved Queen Elizabeth II subsequent to the General Election that occurred on the Twelve Day of December 2019, committed treason in an act of sedition, by way of voting Parliament Sovereign.

We await patiently for forty days, and forty nights, your Majesty's royal command in this matter, before continuing to follow due process of law, and humbly beg sirs' forgiveness, if we have erred in law to date, or if sir feels our further delay is unnecessary in the defence of your Majesties kingdom.
